PURPOSE

This procedure presents the general, basic requirements for conducting human health and/or ecological risk assessments under the management of the Bechtel Jacobs Company LLC as the Managing and Integrating contractor for the United States Department of Energy (DOE), Oak Ridge Operations (ORO).

SCOPE

This guidance applies to those Bechtel Jacobs Company LLC, Project Managers and designated technical staff who will oversee or perform this work in Oak Ridge, TN, Paducah, KY, and Portsmouth, OH, DOE-ORO facilities and associated project sites within the scope of the M&I Contract.

This procedure does not provide detailed technical requirements for conducting human health and/or ecological risk assessments. Additional technical guidelines and/or procedures needed to perform the work shall be provided by the Bechtel Jacobs Company LLC project or the Bechtel Jacobs Company LLC subcontractor performing these specific tasks. Such guidelines and/or procedures will be needed to ensure that permit and/or regulatory and technical requirements are satisfied and provided to conduct the task.

WHAT TO DO

A. Planning for Conducting Human Health and Ecological Risk Assessments

Manager of Projects or designee

- 1. Identify the project's needs for conducting human health and/or ecological risk assessments.
- 2. Inform the Environmental Services Manager of the project's needs for conducting human health and/or ecological risk assessments.

Environmental Services Manager or designee

- 3. Assist Project Manager with input for conducting human health and/or ecological risk assessments in project plans and decision documents.
- 4. Consult with the Project Manager on the need, purpose, and function of the human health and/or ecological risk assessments

Manager of Projects or designee

- 5. Develop plans consistent with the requirements of this procedure, project plans, and decision documents.
- 6. Ensure that the human health and/or ecological risk assessments are conducted in a manner that will provide interpreted, representative data, based on accepted calculations, methodology, and techniques.
- 7. Authorize any deviations from the specified human health and/or ecological risk assessment task and/or applicable procedure.

B. Subcontract for Human Health and Ecological Risk Assessments

Manager of Projects or designee

- 1. Prepare input for the statement of work and technical specifications for the subcontracted task that includes a reference to this procedure and any other implementing company procedures.
- 2. Perform other tasks related to the subcontract as specified in applicable Procurement Procedures on subcontracting.
- 3. Ensure that the selected subcontractor has the necessary technical skills, detailed technical procedures, and methods to conduct the human health and/or ecological risk assessments.
- 4. Review and approve the subcontractor implementation plan(s).

C. Initiation of Work

Subcontract Technical Representative

- 1. The appointed Subcontract Technical Representative (STR) is required to read and understand their responsibilities prior to initiation of work. These responsibilities can be found in the following procedures:
 - FS-A-0010 STR Program plan,
 - FS-A-0012 STR Requirements for Subcontract Formation
 - FS-A-0013 STR Requirements for Subcontract Execution
 - FS-A-0014 Subcontract Closeout Procedure
- 2. Read the subcontract to gain a complete understanding of the scope of work, technical specifications, and deliverables.
- 3. Verify that all deliverables required prior to initiation of work have been supplied (e.g., bonds and certificates of insurance) by the subcontractor and are acceptable.
- 4. Ensure that the subcontractor's personnel conducting the human health and/or ecological risk assessments have been properly trained, and are familiar with applicable procedures and guidance before initiating any work.

D. Human Health and Ecological Risk Assessments

- 1. Perform the human health and/or ecological risk assessments according to approved implementing procedures, protocols, and accepted guidance.
- 2. Conduct human health and/or ecological risk assessments according to the technical specifications of the subcontract.
- 3. Contact the STR to obtain answers to any questions during performance of the subcontracted work.
